

South Jersey Gas Smart Energy Partners program offers financial incentives for high-efficiency natural gas equipment and other energy-saving improvements. The program is designed to help residential and commercial customers reduce energy usage and save money.

## How to Participate

- Review and agree to the Program Terms and Conditions.
- Purchase and install either **a.)** qualified Combi Gas Boiler or **b.)** qualified Natural Gas Furnace or Boiler **AND** qualified Tank or On-Demand Gas Water Heater. (See equipment and efficiency requirements)
- Submit this application **along with copies of equipment invoices** within 180 days of equipment purchase date.
- Complete a Home Energy Assessment by a South Jersey Gas (“SJG”) Home Assessor after equipment installation. **(NOTE: Upon receipt of this application, a South Jersey Gas representative will contact you to schedule your home assessment)**

## Terms and Conditions

- Customer must be the current South Jersey Gas account holder for the installation address associated with this application.
- Customer must complete a home energy assessment performed by a South Jersey Gas Home Energy Assessor to be eligible for a rebate.
- It is the responsibility of the customer to make sure all Program requirements are met and all required documentation is provided to South Jersey Gas. Failure to provide required documentation will prevent processing of the application.
- If the customer portion of the rebate is to be assigned to another party for payment, the account holder must authorize this action by completing and signing the Third Party Payment section of the application form.
- The completed application form and all required documentation must be received within 180 days of equipment purchase date.
- South Jersey Gas reserves the right to request proof of purchase including credit card receipt or statements showing charges paid, or a copy of the front and back of a cashed check.
- Energy Efficiency ratings of installed equipment must comply with those listed in the Air Conditioning, Heating and Refrigeration Institute (AHRI) Directory for space heating and water heating equipment.
- Please allow 30 days to process the rebate after complete documentation is received.
- South Jersey Gas reserves the right to request and review Manual J and ACCA Manual S documentation as well as to inspect, or have inspected, all installed equipment for compliance with Program requirements prior to authorizing the rebate.
- South Jersey Gas' programs expire December 31, 2021 subject to NJBPU's approval, or until funds are exhausted..

- This Program is subject to New Jersey Board of Public Utilities regulatory rules and orders. South Jersey Gas reserves the right to change any portion of the Program or end this program without notice.
- Installations must be completed in accordance with all laws, codes and other requirements.

### EXCLUSIONS

- South Jersey Gas customers participating in the SJG HVAC Loan Program are not eligible for this program.
- Equipment installations in newly constructed homes are not eligible for this Program.
